

## Scientific Paper Presentation- Healthcare Summit 2025

We invite abstracts for paper presentation for the 5<sup>th</sup> **Healthcare Summit 2025** to be held on 14<sup>th</sup> of June 2025 at IISc Bengaluru.

Only original trials/clinical studies or Systematic Reviews/ Meta-Analysis will be accepted for the competition. Both qualitative and quantitative studies, animal studies, as well as in vitro studies will also be accepted. The competition is open to all medical students, interns, post-graduates, PhD scholars, clinicians, staff members, and clinical researchers, including those in Integrative Medicine. Those papers with a primary focus on basic Sciences such as Physiology, Biochemistry, or allied subjects that support understanding human health will also be considered for the presentation.

**No narrative reviews or case reports/ case series/opinion articles, or any other form of work, will be accepted.**

### **The rules of the abstract are as follows-**

- The abstract should be typed in a word file, Times New Roman Font, 12 font size and with 2 spacing. It should not be more than 500 words and should fit in 1 page, portrait layout only.
- The abstract should have the following-
  1. Name of the presenter, associated institution (if any), degree, and email id with phone number.
  2. Title of the study
  3. Introduction
  4. Aim and objective
  5. Methodology
  6. Results
  7. Conclusion
  8. Key words- 3-5 (MeSH terminologies only)

The abstract should be free from plagiarism, spelling, and grammatical errors.

There are limited entries to the competition. No delays will be accepted. If the above terms of abstract submission are not met, the abstract will be rejected, and NO NOTIFICATION will be provided to the candidate.

Those whose abstracts are accepted by the screening committee, will be intimated via email regarding the paper presentation. The decision of the Screening committee is final and no further requests for acceptance will be accepted. No reasons for rejection will be provided to the candidate.

**Rules for paper presentation.**

- The paper presentation will be in person at the venue of the conference. The schedule and sequence of the presentations will be duly provided to the candidate.
- The paper should not be more than 7 minutes. There will be a 3-minute Q&A session from the audience and the judges alike. So the candidate is expected to be prepared accordingly. No further time (beyond 7 minutes) will be provided. The presentations should be in the form of PPT (Microsoft PowerPoint 1997-2003 format only). The PPTs need not be sent via email or otherwise. It has to be carried by the selected participant on a clean pen drive. No other support apart from a projector and a system to upload the presentation will be provided to the participant. No other software support will be ensured during the presentation. It is the sole responsibility of the participant to ensure that the format of the PPT is compatible in general with the system at the venue.
- The decision of the judges regarding the prizes will be final and cannot be challenged in any manner.
- All participants will be provided with a participation certificate. In case there are errors in name or affiliation (which were mentioned in the abstract submission), the organizers will not undertake the responsibility of providing corrected certificates. Hence, due caution is advised while submitting the abstract for the conference.
- Registration for the conference is compulsory for paper presentation. Those candidates not registered for the conference and participating only in the paper presentation will not be provided with any certificate.
